NOTE - NO WARRANTY OUTSIDE INDIA

- Warranted being against defective manufacture, the liability of the company under this warranty is limited to making good, defects arising only from defective workmanship or the use of faulty material. Consequential liability will not be entertained.

- The warranty commences from the date of delivery of the original buyer.
- Tear off portion of DATA CARD needs to be filled in completely & handed over to AMCO Dealer from which the battery is being purchased. The dealer will arrange to send this to the nearest AMCO Branch Office for warranty registration.
- The completely filled warranty card along with a copy of cash memo/bill must be submitted while preferring any warranty claim.
- The electrolyte used should confirm to IS 266 and distilled water to IS 1069.
- The battery should be serviced only by AMCO Service Station by AMCO Authorized Dealers.
- The claim should be made by bringing the vehicle, in which the claim battery is fitted to identify the problem.
- Tampering or overwriting of battery serial number, manufacturing code and date of sale on the warranty card and on the battery will invalidate this warranty claim.
- Claims should be made through nearest AMCO Service Centre or through AMCO Authorized Dealer from whom the battery was purchased duly producing warranty card & cash memo.
- The Serial No. on the battery should match with the Serial No. on the warranty card in order to consider the claim under warranty for adjustment.
- The battery should be returned unopened and complete with electrolyte “freight paid” to the nearest AMCO service outlet. In all claim, the company’s decision will be final and legally binding.
- If the containers, covers or parts damaged due to negligent maintenance or tampering or if these are destroyed in an accident such as fire, wreckage or explosion, then the warranty becomes void.
- If the defects are due to faulty or spurious electrical system, negligent maintenance, incorrect charging or improper handling and servicing of the battery, then the warranty is nullified.
- The right to determine whether or not a battery needs repair or replacement rest with the company.
- In case the battery is replaced, the defective battery being replaced will become the property of the company and no scrap rebate will be given for it.
- The warranty period on the battery being repaired or replaced on free of cost shall commence from the date of sale of the original battery as stated in the original warranty card and not from the day it is repaired or replaced.
- In the event of any particular battery model being phased out, then the company will provide another model of the same/nearer capacity battery which will suit to the vehicle, as settlement of warranty.
- The service record on the warranty card must be filled in only by the authorized dealers of the company as a proof of specified maintenance.
- Octroi duty or local taxes if any becomes liable for the battery under repair or replacement shall be borne by the customer.
- Recharging is not covered under the purview of this warranty and will be charged extra.
- In case of any requirement of any assistance, customers are requested to contact the nearest office of AMCO Batteries Limited or AMCO Authorized Dealer.

- The warranty becomes void if any extra fittings of higher wattage DC loads fitted other than recommended by the original Equipment Manufacturer.
- Ensure the charging voltage setting between 14.2 Volts to 14.4 Volts only. If the charging voltage setting is higher than the recommended value, will shorten the service life of the battery. Higher setting will result in rejection of claim

All Liabilities under This Warranty shall causes if the battery is,

- Transferred to third party or any other vehicle.
- Used in any application other than that specified vehicle application.
- Failure of battery due to Deep Discharging, over charge.
- Customers are deemed to have read, understood and agreed to these conditions at the time of purchase.
- The warranty is issued subject to the jurisdiction of civil courts at Chennai.
